Biological control of invasive species on the South Atlantic UKOTs

A new feasibility study, funded by DEFRA, for the biological control of invasive alien species (both arthropod and plant species) introduced into the South Atlantic UK Overseas Territories (UKOTs) has begun. The title of the project, which is being conducted by CABI and administered through JNCC is 'Understanding and addressing the impact of invasive non-native species in the UK Overseas Territories in the South Atlantic'. The project builds on the results of the South Atlantic Invasive Species (SAIS) project and will link directly into the strategies and recommendations derived from that project.

A major component of this study will be a desk-based review assessing the impact of non-native plants and invertebrates in the South Atlantic UKOTs. Two detailed case studies will evaluate the potential of implementing a biological control programme against priority species for the Falklands and South Georgia more closely.

Update on Eradication of Rodents on Henderson

In August, the Royal Society for the Protection of Birds (RSPB) in partnership with the Pitcairn Islands Government began its rat eradication programme. As part of this partnership, with several international organisations, a single operational vessel will complete three Island restoration projects in succession around the Pacific.

The MV Aquila, will complete a 27,000km voyage to Palmyra Atoll (USA), the Phoenix Islands Protected Area (PIPA, Kiribati) and then Henderson Island, restoring crucial seabird habitats at each stop by removing rats.
